
The broad objectives of the Trust shall be as follows:


All funds of the trust shall be invested in banks or securities in accordance with the provisions of the Income-tax.

The board of trustees may from time to time make rules, and by laws for the conduct of the business and administration of the trust.



XIII) Not more than 5% of the Income of the Trust / institution would be applied for any religious purpose or given to religious institutions.


XIV) AMENDMENT:


04.08/2019 XV) DISPUTES AND ARBITRATION:

All disputes arising between the trustees themselves and the disputes between the Trust and its employees on any matter or subject relating to the affairs of the trust or its institutions shall be decided by a board of three arbitrators appointed by the Board of Trustees from time to time and the award of the arbitrators on such matters shall be final and binding on all the parties concerned.

APPEAL : Except on grounds referred to in Sec.30 of the Arbitration Act, 1940 no appeal would lie against the Board of Arbitrators.

XVI) DISSOLUTION:

This deed of declaration of Trust and the Trust herein declared is irrevocable, However both the life trustees can decide to dissolve the trust and in such on event the properties shall be transferred to societies / trusts with similar objects and registered under appropriate legislations.


